### PUBLIC PATH DIVERSION AND DEFINITIVE MAP AND STATEMENT MODIFICATION ORDER 2018

The above order, made on 24<sup>th</sup> July 2018 under Section 119 of the Highways Act 1980 and Section 53A(2) of the Wildlife and Countryside Act 1981, will divert parts of Public Footpath Nos. 34, Chardstock and All Saints, running from their current route along a track to the west of Yarde Farm to a line running from across fields to the east of Yarde Farm, as shown on the order map.

Any representations about or objections to the order must be sent in writing to the County Solicitor, Devon County Council, County Hall, Exeter, EX2 4QD not later than 12<sup>th</sup> September 2018. **Please state the grounds on which they are made.** Copies of any objections or representations received may be circulated to interested parties.

If no such representations or objection are duly made, or if any so made are withdrawn, the Devon County Council may confirm the order as an unopposed order. If the order is sent to the Secretary of State for the Environment, Food & Rural Affairs for confirmation, any representations or objections which have not been withdrawn will be sent with the order.

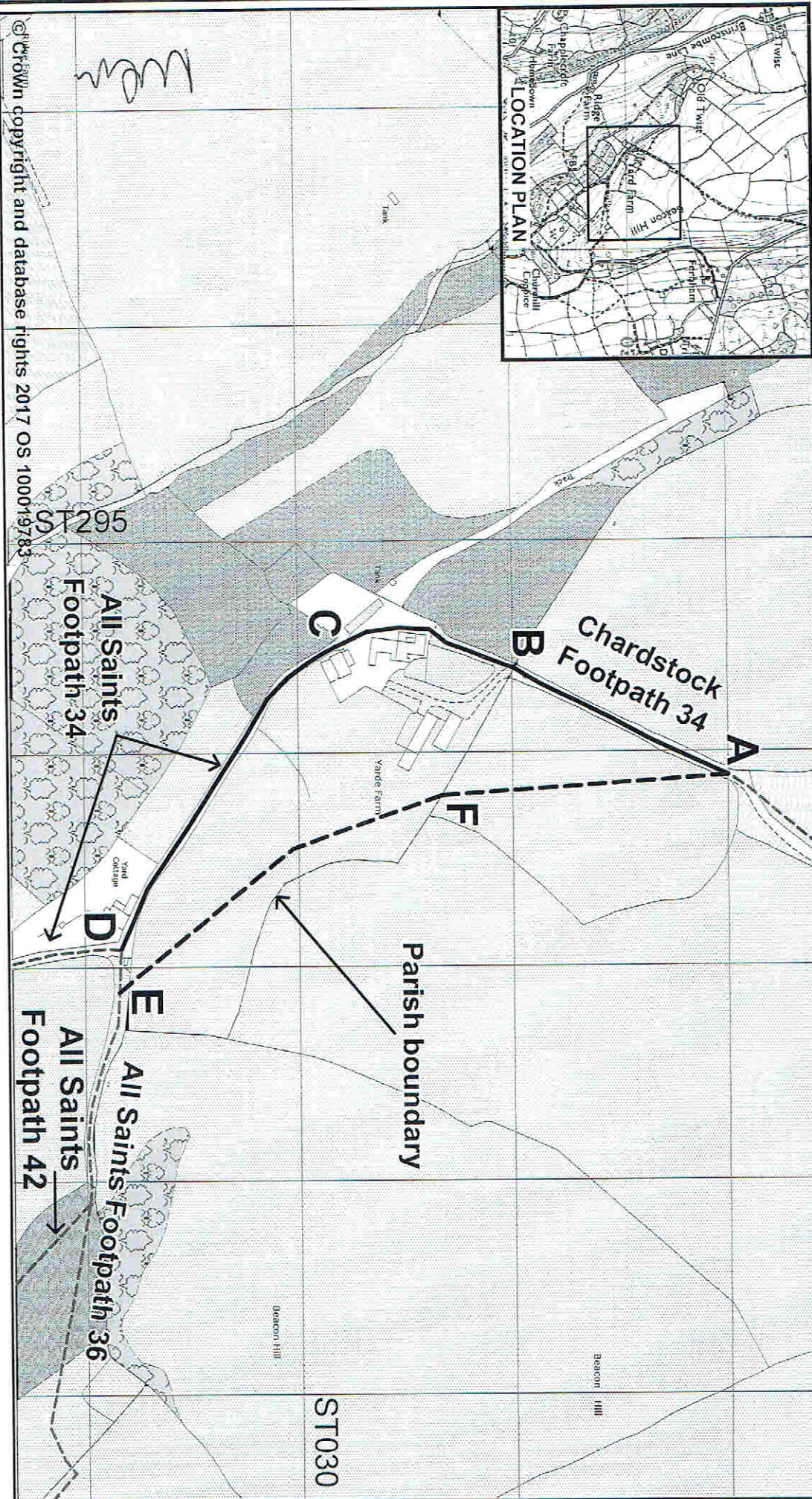
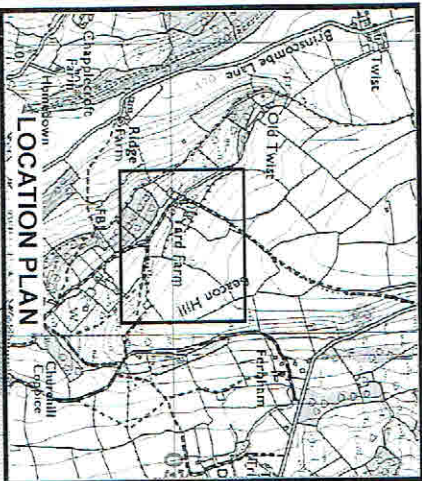
